EXECUTIVE SUMMARY

The Township of Wayne, located in Passaic County, New Jersey is a 26.6 square mile suburban community with over 50,000 residents. It first achieved direct entitlement status in fiscal year 1990. The township continues to provide varied housing opportunities as well as expanding opportunities for improvement in the quality of life of its residents. The use of Community Development Block Grant (CDBG) funding has been an important tool in meeting this goal.

As required by federal Department of Housing and Urban Development regulations, every grantee under the CDBG Program is required to prepare and make publicly available an end of year Consolidated Annual Performance and Evaluation Report (CAPER). This CAPER report covers the Township's CDBG expenditures from January 1, 2008 to December 31, 2008 and is formatted to satisfy the federal reporting requirements. As required, in addition to this narrative, various financial reports as generated by the Integrated Disbursement System (IDIS) are attached.

For fiscal year 2008 the township received \$195,210.00 in CDBG monies that were used for infrastructure improvements in CDBG eligible areas. These improvements included park upgrades to Boulevard, Wayne, Fayette and Minnisink Parks located in the Old Wayne section of the Township totaling \$69,210.00. The township also resurfaced Julie Place and Delaware Drive for a total expenditure of \$98,500.00. The balance of the funds was used for administrative support including the use of consultant services to assist the township in managing the program. The township also projected to complete four units of housing rehabilitation of income eligible households of which only one was completed. Reasons for the shortfall are detailed within this report.

SUMMARY OF RESOURCES AND DISTRIBUTION OF FUNDS

A total of \$195,210.00 in CDBG monies was allocated to the township which was utilized solely by the township and distributed to the Parks Department and Engineering Department. No supplemental funding was incorporated into funding any of the projects identified in the 2008 Action Plan. The attached plan indicates the location of the areas where CDBG funding was utilized.

ASSESSMENT OF THE RELATIONSHIP OF CDBG FUNDS TO PROGRAM GOALS AND OBJECTIVES AS STATED IN THE FIVE YEAR CONSOLIDATED PLAN:

The township continually assesses the relationship of CDBG funding to its five year Consolidated Plan. This analysis indicates that the township is expending its funds in a manner that is consistent with its consolidated plan priorities.

As indicated in the 2005-2009 Consolidated Plan under which the 2008 activities took place, non-housing community needs such as infrastructure repair were anticipated to gain more importance over the next five years as the Township worked towards satisfying its affordable housing requirements pursuant to its affordable housing plan. The deterioration of infrastructure associated with low and moderate income neighborhoods is viewed by the township as a contributing factor towards creating blight and must be addressed in order to stabilize these neighborhoods from further deterioration and disinvestment. It is noted that the Township of Wayne collects funds specifically dedicated to affordable housing issues pursuant to an

ordinance adopted by the township as part of its certified Mount Laurel Plan approved by COAH. These funds are intended to be used in a manner that will promote affordable housing opportunities for low and moderate income families.

The township's long term strategy therefore, is to utilize CDBG monies to address infrastructure issues in income eligible neighborhoods while utilizing its affordable housing fund to address specific housing issues such as rehabilitation, rental subsidies and other similar type programs. This priority is clearly reflected in the township's 2005-2009 Consolidated Plan.

The township's 2008 CDBG program was primarily directed towards meeting infrastructure needs which was identified as a growing need in the 2000-2005 Consolidated Plan and now identified as the top priority for the township in its 2005-2009 Consolidated Plan.

The township applied its 2008 CDBG allocation according to the following projects:

a) Road Resurfacing Program

The township undertook a road renovation/resurfacing program to bring current substandard road conditions up to acceptable engineering standards. Streets included in the 2008 Action Plan were: Julie Place, Dawn Place and Delaware Drive. These roadways serve the same resident population service area (see attached map) but were each analyzed individually to insure project eligibility. These streets are all located entirely within Census Tract 2461.04, Block Group 1 which is a CDBG eligible census tract containing a low and moderate population of 33%. The minimum threshold for CDBG eligibility for the township is 26.2 % consequently; this is a CDBG eligible area. The original budget amount allocated was \$110,000.00 of which only \$98,000.00 was spent. Due to the high cost of oil at the time of the contract, paving costs soared so that the township was only able to pave Julie and Dawn Place. Delaware Drive was deferred for improvement to another time.

b) Park Upgrade Program

The Department of Parks and Recreation undertook improvements and upgrades to Fayette Park, Minnisink Park, Wayne Park and Boulevard Park. The upgrade and renovation project was intended to improve the facilities and included the following:

30 Tons of rubber play ground surfacing for Boulevard Park, Wayne Park, Fayette Park and Minnisink Park.

Boulevard Park – Rebuild baseball backstop with trex lumber
2 Players benches
2 Park benches

Boulevard Park - Install tot play area

Wayne Park – Replace small slide on small composite structure
Rebuild baseball backstop with trex lumber
1 Set of bleachers
Replace 1 tot seat

Fayette Park - Rebuild baseball backstop with trex lumber

- Remove and replace all chain link fencing around baseball field including batters cage
- 2 Park benches
- Gate to ball field
- Line parking lot & install no handicap parking signs
- Yellow protective PVC for top of fence around ball field including tool and ties to install

The original budget allocated to the project totaled \$69,210.00. All the monies were utilized to complete the park improvements as described.

ACTIONS TAKEN TO AFFIRMATIVELY FURTHER FAIR HOUSING

The Township completed an Analysis of Impediments to Fair Housing in 1993. This analysis was recently reviewed in light of the preparation of its 2005-2009 Consolidated Plan and found to be a still valid document for guiding the Township's Fair Housing policies. It is noted that the township is obligated under state Fair Housing regulations to maintain an affirmative marketing plan as part of its substantive certification granted the township by COAH. The township has prepared and submitted to COAH its Affordable Housing Plan for the third round of affordable housing regulations which incorporates an affirmative marketing component as part of meeting its continuing obligation to satisfy its third round affordable housing obligations.

EVALUATION OF PROGRESS IN MEETING THE OBJECTIVE OF PROVIDING AFFORDABLE HOUSING

The Township continues to implement its Fair Share Housing Plan in furthering its obligation to provide a variety of housing types affordable to low and moderate-income families and seniors. It should be noted that the township has affirmatively satisfied its Mount Laurel obligations to provide for affordable housing opportunities under the State Fair Housing Act. A large measure of the township's compliance was achieved through actual construction of low and moderate income affordable units and is strong evidence of the township's commitment to provide affordable housing. These efforts are detailed in the township's Consolidated Plan. The township has prepared and submitted its third round affordable housing plan to COAH and is awaiting state certification of its plan.

CONTINUUM OF CARE NARRATIVE

Wayne Township, through its Social Services Division within the Health Department and the Wayne Counseling Center, a non profit organization, as well as various programs for senior citizens and others, has a well established network to identify and prevent its citizens at risk from becoming homeless. The township assists those individuals and families that qualify with Section 8 certificates and vouchers. The township also offers assistance in home improvements to income eligible residents. The Paterson Coalition for the Homeless provides transitional

housing for homeless persons in the region. It should be noted that the Township of Wayne has an extremely small population of homelessness as reflected in the limited referrals made by the township's Social Services Division which indicates that homelessness is not a major community issue in Wayne.

Passaic County leads the Continuum of Care. During 2007 the following activities were funded by HUD:

OTHER ACTIONS

Address obstacles to meeting underserved needs. Wayne Township seeks to provide services and affordable housing to underserved populations in a number of ways:

1. The enactment of new zoning standards is an important step in our initiative to eliminate barriers to affordable housing and promote affordable housing. Wayne has enacted such rezoning to promote specific affordable housing developments. In addition, fast track local approvals are planned to assist affordable housing sponsors commence construction more quickly, thereby saving time and money in developing their projects. Wayne has also agreed to provide tax abatement, to the extent permitted by state law, to the senior citizens and handicapped housing developments in order to achieve lowered operating costs and thereby lowering rents.
2. The township provides support services for homeless (or potentially homeless) individuals through the staffing of the Welfare Department and allocating funds for assistance which are reimbursed by the State of New Jersey. The township expects that the Welfare Department staff will continue its efforts to assist homeless individuals and that Passaic County will provide services to homeless families. It is important to note that there are not a significant number of people who need assistance of this nature in Wayne, but the township believes that these are important services to provide, even if a small percentage of Wayne's residents are provided with assistance.
3. The Welfare Department staff continues to participate in educational and training activities to become better equipped to serve the homeless. The department is in the process of computerizing its records and resource material. Maintaining up to date information on the various homeless shelters and food providers in the region is important in providing effective counseling and referrals for those in need.

Foster and Maintain Affordable Housing. During 2007 Wayne Township amended the CDBG Program to provide rehabilitation funding to low and moderate income homeowners. This program will provide low income homeowners a means to maintain their homes and the affordable housing stock in the community.

Eliminate Barriers to Affordable Housing. As described above, the township's zoning ordinance and COAH approved Affordable Housing Plan provides incentives and time frames which promote the development of affordable housing.

Overcome Gaps in Institutional Structure: Wayne Township has not identified any gaps in its institutional structure that are impediments to achieving the goals and objectives stated in its consolidated plan.

Public Housing Resident Initiatives. Wayne Township does not have any public housing under its jurisdiction and therefore, does not have programs for public housing residents.

Lead Based Paint Hazard. The Township Housing Improvement Program (HIP) guidelines require remedial action to be taken to correct evidence of lead paint. The Township Health and Social Services Departments provide lead paint screening on a regular basis as well as identifying hazardous conditions and bringing this information to the attention of the departments responsible for remediation. The HIP Coordinator has been trained and is familiar with current HUD lead paint guidelines which will be implemented should CDBG funding be utilized. The Township will utilize certified third party Lead Based Paint Inspection companies to insure compliance with HUD lead paint guidelines.

Anti-poverty Strategy. The Township's anti-poverty strategy consists of the kinds of programs and services described above. The Township works individually with persons who need services.

Ensure compliance with program and comprehensive planning requirements. The Township has an ongoing relationship with the New Jersey State Council on Affordable Housing. Although the Township has met and exceeded its requirements to provide affordable housing and the opportunity for affordable housing choice, the Township maintains close ties with COAH and an open dialogue regarding low and moderate income housing in the Township and the region. This relationship is ongoing and continues as the township proceeds with COAH certification of its third round affordable housing plan.

Through public hearings twice each year the community is given opportunity to review and comment on the Townships utilization of program funding. A consultant was brought on board in 2007 to assist the Township on matters of program compliance.

LEVERAGING OF RESOURCES

For CDBG funded projects, no outside funds were included in the completion of these projects. Township Parks personnel were largely utilized in the labor associated with the park upgrade project which constitutes a non-monetary contribution of resources to this specific project.

SELF EVALUATION STATEMENT

The administration of CDBG funds and the coordination of CDBG eligible programs and projects are handled primarily by the Township Planner located in the Planning and Zoning Department. As such, the department is at the center concerning all aspects of community development and planning. The Department therefore, is in the best position to constantly assess and re-assess the conditions directly impacting community development. There is an ongoing process of constant evaluation and monitoring. The Planning Department provides continuous planning support to the township regarding planning and development activity and has a direct responsibility for this activity.

Wayne Township is a stable community and therefore, not subject to major social, demographic and economic forces which drastically alter the character of the community. The major issues the Township continues to address are an existing aging housing stock, an aging resident population, and an aging infrastructure. These issues, along with stormwater drainage and flooding along the Passaic River corridor, the effective and efficient use of municipal and other resources, and general livability of the community, remain priorities to be constantly evaluated and addressed by all available means.

An evaluation of the township's CDBG program and its accomplishments under this program indicates that the township is pursuing priorities that are consistent with its plans and consistent with the needs of the community.

MONITORING

The activities of the CDBG program are monitored continually. Since there are no sub-recipients, all work is done by township staff. Bid documents, contract management and program compliance are on-going tasks of the staff.

During FY 2007, Wayne Township used 100% of its grant funds for activities that benefit low to moderate income persons.

ASSESSMENT OF USE OF CDBG FUNDS TO CONSOLIDATED PLAN

As a CDBG Entitlement community, the limited amount of funding Wayne Township receives is directed solely for programs and projects which reflect the priorities, needs, goals and specific objectives as identified in our Consolidated Plan. Due to the nature of the funding, we must identify and fund programs and projects that will have the greatest overall impact. We have identified a small number of projects that have directly and consistently benefited the low- and moderate-income persons and households according to the requirements of HUD as outlined in our Consolidated Plan.

As the township constantly reviews community needs, it becomes necessary from time to time to reallocate funding for emerging projects. This reprogramming of funds has been done on a number of occasions in the past and we anticipate that it may be necessary in the future. For the

year 2007 which is the subject of last year's CAPER the township did conduct a reprogramming of funds which allocated \$60,000.00 of Program Income dollars to be dedicated to its Housing Improvement Program (HIP). These funds were collected as a function of recaptured housing rehabilitation mortgages on properties funded by the program and which were sold prior to the six year loan forgiveness term. Under the guidelines of the program, any rehabilitation loans made under the HIP program are repaid should a residence be sold prior to the six year loan term. These funds are recaptured as Program Income and then must be reprogrammed. Based upon the need to address housing rehabilitation applications that were processed in 2007, it was necessary to reprogram these funds to this purpose. The reprogramming was duly advertised and processed in accordance with the requirements of HUD.

As stated previously, the township not only has a limited number of very specific programs and projects meeting the needs of the identified communities, but the township is constantly reviewing and assessing situations and circumstances in light of our current HUD-approved Consolidated Plan to better respond to needs as they arise. Wayne Township, as illustrated by this and prior submissions, has made and will continue to take actions that are consistent with HUD CDBG regulations and its approved Consolidated Plan.

ACCOMPLISHMENTS NARRATIVE:

Housing Improvement Program. The 2008 Action Plan anticipated utilizing Program Income Funds to rehabilitate four substandard housing units occupied by low and moderate income families. Only two applications were processed to completion by applicants. The two applications processed were deemed eligible according to CDBG guidelines however, were not completed in 2008 due to the presence of lead paint which required mitigation that could not be completed in the program year. Consequently, these two units will be rehabilitated in 2009 which will include lead paint mitigation.

Road Resurfacing/Stormwater Drainage Project. Under the Road Resurfacing Project the township completed road improvements to Julie and Dawn Place. The 2008 Annual Plan also anticipated paving Delaware Drive however; this street was deleted from the paving program as there were insufficient funds available to include this street this fiscal year. Paving costs have risen substantially as a result of rising petroleum costs which necessitated the modification.

Park Upgrade Program. The 2006 plan called for park renovations and upgrades to Fayette Park, Minnisink Park, Wayne Park and Boulevard Park. This project was completed as described in the 2008 Annual Plan.
